Dear Alarm Holder,

Alarm systems are a great tool for protecting your property. It's your responsibility to know how your alarm system operates to avoid false alarms. We at the Bolingbrook Police Department take all alarms as true emergencies. That is why the Village of Bolingbrook changed the municipal code Chapter 9-606 (B) (1) & (3) to fine excessive false alarms. Here are some important points you should be aware of as you prepare to activate your system:

Alarm systems are required to be registered. Please return the enclosed form to the Police Department if you have not done so in the past 30 days.

Any alarm system, which generates more than three (3) false alarms in any (12) month period (**ROLLING 12 MONTHS, NOT IN A CALENDAR YEAR**), will be fined using the following rate structure:

4 <sup>th</sup> through 6 <sup>th</sup>	\$75.00	per alarm
7 <sup>th</sup> through 10 <sup>th</sup>	\$250.00	per alarm
11 <sup>th</sup> through 19 <sup>th</sup>	\$300.00	per alarm
20 & up	\$1,000.00	per alarm

Alarms resulting from the following conditions are not considered false alarms:

1. Criminal activity. Crime report filed with the Police Department.
2. High winds or lightning causing physical damage to the protected premises.
3. Flooding of the protected premises due to overflow of natural drainage.
4. Telephone line malfunction verified in writing to the Village by at least a first-line telephone company supervisor.
5. Electrical service interruption verified in writing to the Police Department by "Com-Ed".
6. Communication to the Police Department before a unit is dispatched to investigate, clearly indicating that the alarm is resulting from authorized entry, authorized system test, or other non-criminal cause.
